MOTION TO AVOID (JUDICIAL) LIEN (ON HOUSEHOLD GOODS)
AND NOTICE OF OBJECTION DEADLINE

The debtor(s) hereby move(s) the Court, pursuant to 11 U.S.C. 522(f), to avoid the lien of [name of creditor] on the following (real/personal) property:

If you do not want the court to enter an order avoiding the (judicial) lien (on household goods), or if you want the court to consider your views on the motion, then on or before [date] (**21 days** from the date of service), you or your attorney must file with the court a written objection explaining your position.

If you mail your objection to the court, you must mail it early enough so the court will **receive** it on or before the date stated above.

You must also send a copy of your objection to:

If you or your attorney do not take these steps, the court may decide that you do not oppose an order avoiding the (judicial) lien (on household goods) and may enter an order granting that relief.

WHEREFORE, debtor(s) move(s) the Court to enter an order avoiding creditor’s (judicial) lien (on household goods) and granting such other relief as appropriate.
