B-2070-1. MOTIONS FOR TURNOVER: NOTICE

A trustee who files a [motion for turnover](#) against the Debtor shall provide the Debtor, counsel for the Debtor(s), if any, the UST, and any committee notice of the motion. That notice shall give twenty-one (21) days from the date of service for the filing of any objection. Along with the motion, the trustee shall file a copy of the notice and [certificate of service](#) that complies with S.D.Ind. B-9013-2. The motion, notice, and certificate of service may be combined into one document. A sample combined motion for turnover, notice, and certificate of service is available on the [Court's website](#).
